

# **Supplier Code of Conduct Policy**

A Supplier Code of Conduct Policy summaries the expectations and requirements a company has for its suppliers regarding ethical business practices, environmental responsibility, labour standards, and overall social responsibility. Below is an outline for such a policy:

### Scope:

- Wages and Benefits: Suppliers must pay workers fairly, provide lawful benefits, and comply with wage and hour laws.
- Working Hours: Suppliers must comply with applicable laws regarding working hours and overtime compensation.
- **Discrimination**: A commitment to non-discrimination in hiring, promotion, and training. There should be no discrimination based on race, gender, religion, age, disability, or other characteristics.
- Disciplinary Practices: There should be no harsh or inhumane treatment in the workplace. Disciplinary practices must align with legal standards and be respectful of workers' rights.
- Management Systems: Suppliers must establish a management system that ensures compliance with the SA 8000 standards, with regular audits and the ability to address any non-compliance.



This Supplier Code of Conduct and the SA 8000 standards are part of our ongoing commitment to ensuring responsible and sustainable practices in our supply chain.

### **Health and Safety:**

Suppliers must provide a safe and healthy work environment for all employees, ensuring that their practices comply with applicable health and safety laws. Suppliers are responsible for preventing work-related injuries and illnesses, and for ensuring that their workplaces are free of hazards.

## **Environmental Responsibility:**

Suppliers shall have the proper organization structure, processes and procedures to ensure the protection of personal information against accidental, unauthorized or unlawful loss, destruction, alteration, disclosure, use or access.

#### **Proper Security Measures:**

Suppliers should establish and maintain robust policies and procedures that cover both technical and organizational security measures. These measures should ensure that adequate safeguards are in place to protect data and systems. Additionally, suppliers



must take reasonable actions to verify that they are in compliance with these security policies and procedures.

### **Compliance with Cross-Border Transfer Restrictions:**

Suppliers must implement appropriate safeguards, rules, and procedures to ensure compliance with all relevant laws and regulations governing cross-border data transfers. These measures should protect data during international transmission and ensure legal compliance across jurisdictions.

## **Reporting Violations:**

Suppliers are encouraged to report any violations of this Code or unethical behaviour. Hetero Group ensures protection for whistle blowers who report in good faith, without fear of retaliation.

## **Monitoring and Audits:**

Hetero Group reserves the right to conduct audits or assessments to ensure compliance with this Code. Suppliers are expected to cooperate with any such assessments and provide necessary documentation as requested.

### **Consequences of Non-Compliance:**

Suppliers who violate this Code may face corrective action, which could include termination of contracts or other legal remedies. Hetero Group is committed to working with suppliers to improve compliance, but serious violations will result in consequences.

## **Management Systems:**
